# MINUTES SILVER CREEK TOWNSHIP PLANNING COMMISSION PUBLIC HEARING AND REGULAR MEETING HELD ON JULY 26, 2017

The Public Hearing was called to order by Chairman Terry Harris at 7:00 p.m. on Wednesday, July 26, 2017. The Pledge of Allegiance to the Flag of the United States of America was recited.

### **MOTION TO APPROVE AGENDA**

Dave Grabemeyer motioned, seconded by Jerry Donley, to approve the July 26, 2017 agenda. Motion passed by voice vote.

Chairman Terry Harris read aloud the Notice of Public Hearing for Ordinance Amendment.

No written comments were received.

Tom Lehrer arrived and joined the meeting at 7:05 p.m.

Terry stated the reason for the hearing, which was to review the recommended changes to the Silver Creek Township Zoning Ordinance: adding Food Truck and Food Truck Park to the definitions in Section 155.006 and Special Land Use Standards Food Truck Park in Section 155.000.

Bill Zuhl commented that the definitions are fine. He recommended that instead of Food Truck Park being a stand-alone definition, it could be put in as part of the parameters of õOpen Air Businesses,ö which would be easier. Terry Harris answered that they were talking about doing just that. Bill Zuhl referred to page 157, Open Air Business and stated it is permissible as an open air business. Building/Zoning Administrator Todd Herter stated that he doesnøt know if heød like to see it as a permitted use, but a special land use because if it is permitted, there are no guidelines. Terry Harris referred to 155.150-155.164. Discussion followed.

The Planning Commission discussed adding Food Truck and Food Truck Park in 155.006 and 155.150.
